

Pool Access and SPA Area Regulations Cottage Le Manoir du Coureau

Access to the 1.40 m deep, flat-bottom swimming pool is open from 9:30 am to 9:30 pm, it is free, unattended and uncontrolled. Tenants agree to comply with the safety and health regulations for the benefit of all.

Access to the SPA is open from 10 a.m. to 10 p.m.

Within the framework of French regulations on the use of family pools open to guests, in order to avoid accidents of which children may be victims, and in order to guarantee the maximum safety for all, to make your stay pleasant while keeping the installations in good condition, please observe and respect the following points:

Article 1: Anyone who has not accepted the said regulations by signing at the bottom of the copy given by the owner is not entitled to access the swimming pool and the SPA.

Article 2: Any user of the swimming pool and SPA must be covered by a Civil Liability Insurance defense and recourse. Any accident occurring to a host is under his entire responsibility.

Article 3: The swimming pool is shared between the owner, his family and the tenants of the Gîte du Manoir du Coureau. Tenants are strictly prohibited from inviting third parties to use the pool.

Article 4: The bathing of children must take place under the supervision of a responsible adult who can swim (In case of force majeure, there is available a lifebuoy and a pole attached to the wall of the shed) . It is forbidden to swim alone without supervision.

Article 5: The owner reminds all his customers of the absence of surveillance of the swimming pool.

Article 6: The swimming pool is equipped with an alarm to standards, operated only by an adult. (The floating curtain will be positioned soon)

Article 7: Users agree:

- To take a shower before accessing the pool (it is forbidden to access the pool with a sunscreen or sun oil on the body)
- Not to swim at night
- Not to urinate in the basin

- To use a swimsuit only reserved for the use of swimming
- Not to bring food or drink, except still water, near the swimming pool
- Not to shout and organize violent games around and in the swimming pool
- Not to throw objects, stones, pieces of wood, or anything else in the basin (Any damaged or destroyed material will be charged to the person in charge).
- The use of buoys and other equipment is the responsibility of the tenants
- Not to raise the protective flap. If this is in place, the basin should be considered closed
- Not to use in the garden the white towels intended for the bathrooms.

Article 8: The garden furniture available around the pool is the responsibility of the tenants who will have to take all measures and precautions to keep it in good condition (fold the ping pong table and cover it, put the seating in the sheltered garden in case of rain)

Article 9: Use of the SPA area

The SPA, SAUNA and HAMMAM area is reserved for adults or minors accompanied by an adult and responsible person.

The use of the SPA area is authorized from 10 a.m. to 10 p.m.

It is prohibited to modify the SPA temperature settings.

It is forbidden to bring food and drinks, except plain water, into the SPA area.

The SPA protection cover and tarpaulin must be replaced after each use, in order to avoid accidents and maintain the temperature.

Article 10: The owner on repeated failures to one of his articles, can withdraw the authorization that he previously granted without compensation whatsoever.

Article 11: The cleaning of the basin and the filter is carried out regularly by the owner. Small dirt on the surfaces can be picked up with the net provided for this purpose by the tenant in the absence of the owner.

Article 12: Pets are prohibited in and near the Pool and SPA areas.
